This contract between Drive! Driving School and (student name) _____, covers a course in Driver Education, which includes _____ hours of behind-the-wheel instruction. The fee for the course is \$50/hour. If mailing payment, please send check or money order only. We will not accept cash.

Drive! Driving School and the student agree to the following terms and conditions.

1. All fees are payable in advance before the first training session. Payment can be made using a credit card, debit card personal check or money order.
2. All educational materials issued are the property of Drive! Driving School and they must be returned in good condition at the completion of the course.
3. Cancellation of driving and testing appointments must be made at least 24 hours before scheduled appointment. Student will be charged \$50 if cancellation is made less than 24 hours before the appointment begins.
4. No certificate of completion will be issued until all fees have been paid in full.
5. There will be a \$35.00 service charge for all returned checks.
6. Drive! Driving School will complete the course within a reasonable length of time however, it cannot be held responsible for delays caused by unsafe driving conditions due to bad weather, mechanical problems, or any other reasons over which it has no control. Drive! Driving School will provide as much notice as possible if a delay becomes necessary.
7. The fees contained herein cannot be guaranteed longer than ninety (90) days from the beginning date of the course.
8. While Drive! Driving School will exert its best efforts in teaching the student to meet the requirements of the NC Division of Motor Vehicles examination, the school cannot guarantee that the student will successfully pass a DMV exam upon completion of the course.
9. The student must be at least eighteen (18) years of age to agree to and sign this contract.
10. The student may use a Drive! Driving School vehicle for the actual license exam if the student has completed a minimum of six (6) hours behind-the-wheel training. Use of a school vehicle for the Division of Motor Vehicles road test is at the discretion of Drive! Driving School instructors.
11. If a student is approved to use a Drive! Driving School vehicle for the Division of Motor Vehicles road test, a fee of \$100 will be accessed. This fee must be paid in advance of taking the DMV test.
12. Under this agreement an instructor may not provide behind-the-wheel training to more than three individual students during one driving session.
13. Drive! Driving School will not refund any tuition monies or any part thereof once actual services have been rendered.
14. This agreement constitutes the entire contract between Drive! Driving School and the student, and any verbal assurances or promises not contained herein shall bind neither the school nor the student.
15. Drive! Driving School is licensed by the State of North Carolina Division of Motor Vehicles.

Refund Policy: We are happy to refund tuition for classroom instruction, less a \$10 processing fee, if you cancel classes two full working days prior to the first class meeting. If a request for a refund is made less than two working days prior to the first class, the student will receive a refund equal to 50% of the paid class tuition. If a student cancels a behind-the-wheel session at least 24 hours before a scheduled appointment, the session fee will be refunded minus \$50. If a behind-the-wheel session is cancelled less than 24 hours before the scheduled appointment, no refund will be provided.
